Invitation to submit Expression of Interest (Eoi)

State Council For Vocational Training (SCVT) established under the aegis of the Department of Vocational Education, Skill Development and Entrepreneurship, Govt. of UP as a society under the Societies Registration Act, 1860 has been accredited as Awarding Body (Dual) by the National Council for Vocational Education and Training (NCVET), Govt. of India for undertaking assessments and certification of the youth in the State receiving training under various skill training programs contributing to fortify the skill ecosystem of the state and expedite assessments and certification process.

In order to operationalize the assessments and awarding verticals State Council For Vocational Training intends to invite application from the assessing agencies already shortlisted by the NCVET for empanelment in the SCVT to undertake assessments assignments in different sectors in the State of Uttar Pradesh.

Instructions to the Applicant or Awarding Jobs

1. Interested Assessment Agencies are required to submit duly filled application form only in hard copy. Nevertheless the details concerning work orders or other requisite documents carrying substantial volume may be stored in a pen drive and the same may be provided with the proposal.
2. The Application form may be downloaded by the interested parties from the SCVT website (www.scvtup.in), where it appears under a separate caption **"Expression of Interest (EOI) Empanelment As Assessing Agency."**
3. The SCVT would upload modification (if any) on the portal at least three days prior to the terminal date for submission of proposals.
4. The interested organizations who wish to apply are, therefore, suggested to regularly navigate through the SCVT website for the latest updates.
5. The applicant organization should fill all the columns even if they do not apply to any particular organization. In such an event the subject column may have an entry of non-applicability.
6. Interested assessing agencies should understand that the assessment should be done for the NSQF aligned courses approved by the NCVET, Govt. of India and those that are congruent to the national qualification register.
7. The SCVT would keep and maintain the rights to audit the assessment process at regular intervals including documentation and performance of the empanel assessing agencies.
8. The applicant organization are required to provide all the requisite details and information deemed mandatory by the NCVET as per their status as on 31 March, 2024.
9. The SCVT reserves the rights to suspend, modify or cancel the empanelment process or disapprove any or all applications without assigning any reason thereof.
10. Each Page of all the Documents and Application form submitted by applicant should be duly signed & stamped.
